2014 NJ Envirothon Recap

Station

The 21st Annual NJ Envirothon was held on May 2 and 3, 2014 at the New Jersey School of Conservation. The School of Conservation is a branch of Montclair State University and is located in Stokes State Forest, Sandyston Township, Sussex County. Our hosts were the Sussex County Soil Conservation District. The Envirothon opened on Friday evening with a delicious dinner, a cozy bonfire, smores and a stargazing/astronomy demonstration led by Marc Rogoff of the New Jersey Department of Environmental Protection (NJDEP.) The facility offered both tent and cabin camping.

The competition itself began early Saturday morning after an early breakfast in the School's dining hall. Participants were welcomed by Dr. William Thomas, Director of the School of Conservation; by Barbara Rosko, the Chairman of the Sussex County Soil Conservation District; by Carrie Mosely, the NJ State Conservationist for the USDA Natural Resources Conservation Service; by Priscilla Hayes, President of the New Jersey Association of Conservation Districts; by Frank Minch of the New Jersey Department of Agriculture and Rich Boornazian, an Assistant Commission of NJDEP.

Thirty three teams participated with a total of 185 students. The theme of the 2014 competition was Sustainable Agriculture. The theme was the basis for the tests at the Environmental Issues station and at the Oral Presentation Station. The Oral Presentation problem was directed at connecting New Jersey agriculture with the student's schools. Students were asked to develop Farm to Schools program for their specific school. In addition, students were also given both written and field tests in: Soils; Aquatics; Wildlife; and Forestry.

The competition was extremely close. The 1st place team was the Marine Academy of Technology and Environmental Sciences (MATES) (Team 1.) Second place was awarded to High Tech High School, (Team 1) and third place was awarded to West Windsor Plainsboro High School (Team 1.) The individual teams who received awards for the highest scores at the individual stations were:

Members of the first place winning team were each awarded \$1,500.00 scholarships.

Awards were also given to the highest scoring new teams (first time competitors.)

The participants celebrated the conclusion of the competition with music from a DJ, and Frisbees. All participants were provided with a gift bag to help remember the day as well as a pine tree seedling to help improve the future of all the citizens of New Jersey.

In reality, all of the participating students were winners. The Envirothon is truly a fun and educational experience. Many of our past participants have gone on to careers in conservation and in the environmental sciences.

As always, the New Jersey Envirothon was a volunteer effort from among the members of the NJ Conservation Partnership. Volunteers included representative of NJ's 15 Soil Conservation Districts, the USDA Natural Resource Conservation Service, the State Soil Conservation Committee and the NJDEP Bureau of Forestry. We thank the many volunteers for their countless hours of service to promote conservation education within our state.
