

Overview

On January 5, 2011 the state of New Jersey enacted New Jersey Act P.L. 2010, c. 112 (C.58:10A-64), which establishes standards for fertilizer applications to turf, requires certification of professional fertilizer applicators, and regulates labeling and sale of specialty fertilizers for turf.

ProFACT provides training and testing for professional fertilizer applicators seeking to become either certified or trained. The training and testing materials were developed by the Rutgers New Jersey Agricultural Experiment Station in consultation with the NJ Department of Environmental Protection and other stakeholders.

For a professional to become **certified**, the individual must pass an exam to certify that they have sufficient knowledge of the laws, rules and regulations, standards and requirements applicable to the use and application of fertilizer.

A \$75 fee will be charged to take the certification exam. Upon passing the exam, an annual certification card will be issued. Certification will be valid for 5 years as long as the professional registers annually (\$25 fee) through the website.
