2022 Education & Outreach Accomplishments:

Although many of our outreach programs in year 2022 continued much like 2020 and 2021, as webinars, due to the ongoing pandemic, the silver-lining is that we also continued to reach a broader audience through our online forum than was ever possible in-person. However, we were excited to offer an in-person 25th Annual Barnegat Bay Environmental Educators Roundtable and celebrate alongside our watershed colleagues the past twenty-five years of offering quality professional development opportunities to our local educators. We look forward to another in-person 26th Annual BBEERT in 2023. Our conservation message is reaching across the state, and beyond, as our "communications toolbox" continues to grow and expand. Our monthly newsletter, social media, blogs, videos and our Annual Report provide myriad ways for OCSCD staff to keep our constituents informed about our many programs, projects, partnerships, events and our latest endeavors. December 2022 – January 2023 Education & Outreach Activities, as per the Annual Plan of Operations:

In support of OCSCD's Annual Plan of Operations (APO), which includes in its vision "to be recognized as a conservation leader", and includes in its mission "to protect, restore and sustain fully functioning soil resources...", "further natural resource stewardship through educational programs..." and "develop and nurture effective relationships... to sustain functioning ecosystem services...", the Education Department is championing the Jersey-Friendly initiative in cooperation with Barnegat Bay Partnership, to effectuate OCSCD's vision and mission. In addition, the Education Department is supporting the OCSCD technical staff on two additional grant projects: Sustainable Practices for Aquaculture Resource Conservation (SPARC) and Lakewood Township Stormwater Basin Retrofit Project. In addition, the Education Department continues to provide community outreach programs and statewide initiatives, as well as research and write grants to support OCSCD's overall mission.

Grant 1: Jersey-Friendly Yards (including subcontract)

- Subcontract with Barnegat Bay Partnership Part 1: Assistance with BBP Communication & Outreach. This
 portion of the subcontract has been fulfilled and is now complete. OCSCD was subcontracting with Barnegat
 Bay Partnership to support watershed-wide education and stewardship initiatives, including Jersey-Friendly
 Yards and Barnegat Bay Master Naturalist Program.
 - Per the subcontract, Becky assisted Karen Walzer, Public Outreach Coordinator for BBP, to provide programs and promote the JFY website as a guide to landscape practices for managing stormwater and reducing nonpoint source pollution in the Barnegat Bay watershed, and engage community members and statewide "Green Groups", including Green Teams, Environmental Organizations, Garden Clubs, in best practices.
 - Per the subcontract, Becky produced a quarterly Barnegat Bay Master Naturalist Newsletter, titled *The Naturalist*. Newsletters can be found on BBP's <u>Master Naturalist Program</u> webpage. <u>Grant 2: Lakewood Township Stormwater Basins Retrofit Project</u>

OCSCD is partnering with South Jersey Resource Conservation and Development Council, Lakewood Township Department of Public Works, and the Camden County Soil Conservation District on a grant from the State of New Jersey Department of Environmental Protection: Lakewood Township Stormwater Basin Retrofit Project. The grant is funded by a Federal 319(h) Water Quality Restoration grant awarded by the NJ Department of Environmental Protection to the SJRC&D.

- Brittany Moore is the OCSCD staff representative managing OCSCD's grant activities, with assistance from Becky Laboy. OCSCD's role is to implement and promote the Lakewood Township Stormwater Basin Retrofit Project.
- 2. (APO Item #4, Activity 2) Seeks Grants and Funding to support both on-going and new initiatives and programs:

 Becky continues to research potential grants that will support the District's Mission. Becky looks forward to collaborating with other organizations, agencies and District staff on application submittals and project implementation. No new grants have been submitted at this time.

(APO Item #5) EDUCATION INITIATIVES

1. (APO Item #5, Activity 1) To maintain and enhance OCSCD website. To more effectively utilize and disseminate pertinent and educational resources and assist in fulfilling OCSCD Mission.

Communications: Website, Newsletter, Blogs, Social Media and Annual Report:

Becky has been using several OCSCD media communications platforms in an effort to engage a broader audience in support of the District's Mission. OCSCD staff have been regularly contributing articles for publication.

- Newsletters continue to be distributed monthly through our Constant Contact platform, typically on the first day of the month, to our audience of 1,777 contacts on our "General List", with an additional 2,294 statewide education administrators (used for our Roundtable campaigns), totaling 4071, of which, 1,070 are considered "most engaged". We have a 40% average email "open rate". Our newsletter offers featured sections such as "Education Programs & Events", "Staff in the Field" and "Partner Projects", where they discuss the latest updates about educational programs, projects and events, as well as grants, current partner projects, technical information regarding SESC Standards, and informative content about soil, water and natural resource conservation in the Barnegat Bay watershed.
- <u>Blog posts</u> on our website highlight the District's many projects, as well as our soil conservation message, and are linked in our newsletters and social media.
- Newsletters, blogs and other soil conservation information are also distributed via the District's social media

- Becky is currently working on the <u>OCSCD Annual Report</u>, highlighting the many projects, programs and partners with which the District staff are engaged.

- 2. (APO Item #5, Activity 2)_Becky maintains communications and networks with regional and statewide Conservation Education and Environmental Education initiatives, including Barnegat Bay Roundtable Steering & Planning Committee, Barnegat Bay Estuary Program's Communication and Education Committee, Conservation Partnership meetings, Natural Resource education Foundation of New Jersey (NREF), Jersey-Friendly Yards.
- **3. (APO Item #5, Activity 3) Poster Contest:** The 2023 Annual Conservation Poster Contest has been announced. This year's theme is "One Water", highlighting the importance of water as a natural resource. The contest information, rules and entry form can be found on our website. Deadline for entries to the OCSCD is March 1, 2033. OCSCD Staff will select the First Place winning posters for each of the four grade groups. The Board will select the Grand Champion Winner among the First Place winners. OCSCD will award the Grand Champion Winner a \$50 cash prize. Winning OCSCD posters can be found on our Annual NJ Conservation Poster Contest webpage. Winning statewide posters can be found on the NJACD website.
- **4. (APO Item #5, Activity 4) Promote the Distribution of Low Maintenance Landscaping Guides.** Becky is currently searching for grants to support funding to print additional LML Guides.
- **5.** (APO Item #5, Activity 5) Barnegat Bay Environmental Educators Roundtable: SAVE-THE-DATE! The District's **26**th Annual Barnegat Bay Environmental Educators Roundtable will take place on April **19, 2023**, at The Lighthouse Center for Natural Resource Education. Details are forthcoming, and will be posted on the OCSCD website, on the Barnegat Bay Environmental Educators Roundtable webpage. Planning for the 2023 BBEERT will continue over the next few months.
- **6. (APO Item #5, Activity 6) Internship & Volunteer Opportunities and Agreements:** The District hosted an intern, Christina Fiocco, over the Fall 2022 semester. Ms. Fiocco worked with the Technical Staff on SESC projects.
- 7. (APO Item #5, Activity 7) Offer a variety of Outreach Programs based on soil health & natural resources to various groups/organizations; at least 12 per year. In 2022, Becky participated in the planning, implementation and/or presentation of 23 programs and events. Becky shares her regrets that she was unable to attend the last webinar program in the Jersey-Friendly Yards 2022 Webinar Series, and the JFY Fall Conference this year, due to a medical leave of absence. (APO Item #5, Activity 8) Envirothon:** The 2023 NJ Envirothon has been announced and will take place in-person, for one day (no overnight) on **Saturday, May 20**, at Camp Zehnder, in Wall Twp in Monmouth County. This year's theme is Changing Climate. Becky is assisting with the creation of the Wildlife Station written-test.
- 9. (APO Item #5, Activity 9) Track Participants, evaluations, provide reports on E&O activities to District Director and Board: Becky maintains constant contact with District Director, Christine Raabe, and provides bi-monthly reports regarding all education activities to the OCSCD Board of Supervisors.
- 10. (APO Item #5, Activity 10) Jersey-Friendly Yards Conference & Webinars: 2022 Jersey-Friendly Yards Webinar Series: Becky attends all meetings of the JFY Conference and Webinar Committee and takes and distributes notes.
 - The JFY Conference & Webinar Committee hosted a 2022 JFY webinar series, "Back to Basics: 8 Steps to a Jersey-Friendly Yard". Each of the 8 webinars reflected one of the 8 Steps to a Jersey-Friendly Yard. Becky presented the first 2 webinars: Step 1 Plan Before You Plant, and Step 2 Start With Healthy Soil.  - ✓ Step 1: Plan Before You Plant in February Becky presented 136 attendees

- ✓ **Step 2: Start with Healthy Soil on March 8** Becky presented **16 attendees** (suggestion create a flow chart that connects to other steps in the series... plus carbon cycle)
- ✓ Step 3: Water Wisely on April 12 Steve presented 57 attendees. Comment came in and was sent to Karen regarding "peat" that is should not be recommended because it holds carbon and it's not good to harvest. Commenter also said it's not good to use cardboard as mulch because it suffocates the soil.
- ✓ Step 4: Fertilize Less on May 10: speaker, Chris Adams of Eastbound LLC. 118 attendees
- ✓ Step 5: Minimize Risks When Managing Pests on June 14: Emily May of Xerces Society. 82 attendees
- ✓ Step 6: Loose the Lawn and Create a Wildflower Meadow Instead on July 12: speaker Patt Sutton presented. 554 attendees
- ✓ Step 7: Create Wildlife Habitat on August 9 Kathleen Kerwin presented. 214 attendees
- ✓ Step 8: Reduce, Reuse, Recycle on September 13 Sandra Blaine-Snow presented. 114 attendees
